My name is Michael Molinaro, I am the Tentative Police Chief of Leet Twp. (Civil service hearing pending) I retained Joel Sansone for Civil Rights case 2:22-cv-882. After a discrepancy with Mr.Sansone requesting several more unplanned payments , I explained to him that I wanted to drop the Civil rights case and focus on my Civil Service hearing. Mr. Sansone stated that if I did not take the settlement and waive my civil service hearing, he would drop me as counsel.

I was not notified of a "Status conference" hearing that was apparently held on the 10th of May. I did not receive any emails, phone calls, or regular mail pertaining to my requirements to appear.

I was only privy to this because Leet Townships employment attorney, Estelle McGrath had sent me an email. This email came in as spam and was opened up on 5/19/2023 at 1:30pm. I promptly contacted the clerk at The United States District Court for The Western District of Pennsylvania and they explained that I needed to write this letter.

After careful consideration and the inept withdraw from Mr. Sansone, I acting in Pro se , would like to fully voluntarily withdraw the entire case as I do not intend on moving forward with any of the violations.




ORDER OF COURT

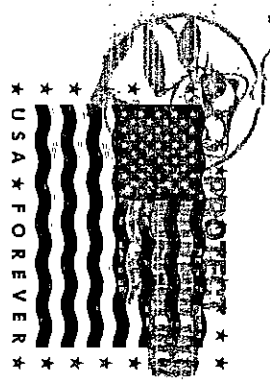
